- There appears to be an increased number of children coming to school sick. We've had to ring parents often to ask them to pick youngsters up. Parents seem to be understanding
- AB taking his sabbatical in Term 3. LB (Mon-Wed) and NL (Wed-Fri) will be the Acting Principals, with Debbie Pratt and Annette Woodhead providing support from the Tui Team.
- Francisca Knottenbelt and Gemma Strother will be release teachers for HG 4 and HG11.
- As Gemma Strother is pregnant, Niamh O'Reilly will return to look after HG3 for Terms 3&4.
- Principal Message to go out Friday, July 8th communicating these changes.
